Next Supervisor Housler discussed the 2020 Federal Poverty Guidelines. These guidelines are for those people that file for the poverty exemption. We usually have one or two people that qualify. Motion by Treasurer Lackie, seconded by Trustee Barnett to adopt the 2020 Federal Poverty Guidelines. Ayes 4, Nays 0.

Supervisor Housler then discussed 3 parcels that need to come off the special assessment district for curbside pickup. Once these are approved, the Treasurer will send amended tax bills. Motion by Trustee Barnett, seconded by Supervisor Housler to remove the following from the special assessment district for curbside pickup. Ayes 4 (Housler, Lackie, Barnett, Lightfoot), Nays 0.

Parcel #009-140-059-00 and 009-220-100-00 – Karl and Barbara Holder are currently charged for two containers and should only be charged for one container.

Parcel #009-060-075-00 – Phyllis Young should be DELETED from the district.

Parcel #009-460-004-00, 009-460-005-00, 009-460-006-00, 009-460-007-00 — Edward Kresky should only be charged for one container.

Supervisor Housler mentioned that next month we will be starting to work on the budget. Right now the Planning Commission only has one item they are working on. He asked the Board whether they had anything else for the Planning Commission to work on. Lacking that, if nothing else comes up, it may not be necessary for the Planning Commission to meet every month. Trustee Barnett agreed, and asked how many times they are required to meet. Supervisor Housler said 4 times per year. Clerk Lightfoot also noted that if we put the Planning Commission down to the required 4 times per year, if something urgent comes up, we can always add a meeting back. We would talk about it more next month.

Supervisor Housler noted that last month he said he was going to check out the list from the Road Commission of LOP roads. Due to illness he wasn't able to check these roads out, but would be following up this month.

Supervisor Housler received a letter from Al's Aerial Spraying wondering if Freeman Township would like additional spraying for Gypsy Moth over and above what the County will be doing. Clerk Lightfoot said it would be hard to say yes since we don't know what the County's spraying will do until it's done. Also, she doubted we could afford it. Treasurer Lackie concurred and said she doesn't believe we have enough fund for this.
