SUPERVISOR'S COMMENTS

Trustee Barnett gave an update on the Shadowbrook property owned by Conrad Blain. The deadline to pay the fine and comply is today 11/10/2022, which hasn't been done. We are waiting to get a date for a formal hearing with a judge.

Trustee Barnett presented the Proposed Brine Dates for 2022, we have requested the same as 2022 which are, May 25, June 29 and August 16. The cost is \$0.209 per gallon.

Supervisor Housler had a meeting with the Clare County Road Commission last week. The price for chip and seal is \$70,000 per mile and blacktop is \$120,000 per mile. We need to let the Road Commission know by December what road projects we would like done. There is no more millings available at this time.

We have several suggestions for additional streetlights, Ashard and Strawberry, Lake Station and Monroe, Monroe and Grass Lake, Shadowbrook and Hemlock, Ashard and Pinehurst, Ashard and Havenwood, Ashard and Ashcroft, the curve where Lake Station becomes Grass Lake

We received a request for a cannabis business in Freeman Township. We have an Ordinance prohibiting cannabis business in our township, and the location is question would have to be rezoned to commercial. Motion made by Clerk LaFave, seconded by Treasurer Lackie to keep

our Ordinance as it stands and not allow cannabis business in Freeman Township. Roll call vote taken. Ayes-4, Nays- 0
