SUPERVISOR'S COMMENTS

Supervisor Housler made a motion to re-appoint the Board of Review members, Geri Shaw, Bob Eckardt, Vicki Brauner and Sheyla Young as required by the State every two years. Motion was seconded by Treasurer Lackie. Roll call vote taken. Ayes-5 Nays-0

Our court date is Wednesday December 14th, 2022 at 2:00pm for the blight issue on Shadowbrook Drive. We would appreciate attendance at the hearing to show our concern and support for compliance with our ordinances. The defendant at this hearing is the property owner of record. We do have a hearing scheduled for January 11th, 2023 at 1:30 and 2:00pm for the two individuals who are occupying the property.

Concerning the 2023 Road Projects Supervisor Housler suggested we invite the County Road Commission in to go over options and costs.

The County Road Commission has a new right-of-way clearing machine and are taking requests for it's use, at a cost of \$2000 per mile. Supervisor Housler asked if there was any areas in our township where this would be useful. Treasurer Lackie suggested the curve on Grass Lake

where it meets Ashard, as it is very hard to see around the curve, others showed support for that area. We will call to make arrangements.

The list for suggested new streetlight locations are –

Ashard at Lake Station, Ashard at Strawberry, Shadowbrook at Hemlock, Monroe at Grass Lake, Monroe at Cook, Ashard at Ashcroft, Ashard at Pinehurst, Spring St at Norway, Lake Station at Adams and Cedar at Garfield. Motion was made by Trustee Sable and seconded by Clerk LaFave to move forward with these location and meet with Consumers to go over options for lighting. Ayes- 5 Nays- 0

Board members were given a copy of the Proposed Planning Commission Ordinance Amendments to read and review for the January 2023 meeting.
