A motion was made by Trustee Sable, seconded by Trustee Barnett to approve the minutes from the July 13th 2023 Board Meeting. Ayes- 5 Nays- 0

GUEST SPEAKERS

Marlene Housler- Clare County Commissioner- Clare County Commissioners approved \$6,500 to repair airport runway.. It was not approved before, but the Road Commission found a company that was willing to donate equipment and labor for the repairs, lowering the cost significantly, it will begin August 22nd

The Michigan legislature is considering a bill that would require every homeowner with a septic tank to have it inspected every 5 years. We are watching this, to see how it will be implemented.

Ken Vandrick- 3879 Lake Tahoe Trail – Purpose to speak tonight is to ask the Freeman Township board to reconsider the Special Assessment District and how it is administered. He then gave a brief history of Lake Tahoe and its Association. Lake Tahoe is a private lake, has a dam and was developed in the 1960's. He is the recent past president of the Association. He expressed his contention with the newly elected board and believes that the property owners, not the board should choose who and how the lake is treated by and if the Assessment should be increased. He would like a separate organization run by the property owners to run the Special Assessment District and make recommendations to the Freeman Township Board.

Supervisor Housler ask for board approval for an additional payment to Michigan Chloride Sales for brine, 9500 gallons in May 2023, for the amount of \$1,777.96. Seconded by Clerk LaFave Ayes-5 Nays-0

Supervisor Housler presented a bid from Blain Excavating for driveway improvements for our cemetery in the amount of \$7,700. This includes road gravel and 70 yards of crushed asphalt on top. Leveled and finished to grade. Motion made by Trustee Sable and seconded by Trustee Barnett, with the provision of an October 1st 2023 deadline. Ayes – 5, Nays- 0

Supervisor Housler gave an update on the Shadowbrook blight situation. The occupants are aware of the August 21st deadline to vacate the property and have been moving some things out. Our hopes are that they will move everything off by August 21st, but regardless we will be cleaning up after the deadline and will attach all costs to the property.

Supervisor Housler proposed a rate increase for the curbside garbage service. Service has been in effect since 2019 we have had two increases from GFL, which has been absorbed and now there is a fuel surcharge. A motion was made by Trustee Sable to increase the rate to \$164.75 per year, seconded by Trustee Barnett. Roll call vote taken, Ayes-5, Nay-0

Reminder the last brine application for dust control is scheduled for August 15, 2023
